TERMS & CONDITIONS - MOBILE CONCRETE PUMP WITH OPERATOR

HIRE RATE:

- Hire rates cover the minimum hours on site and transport to and from site. Additional hours will be charged after the minimum, as applicable. Please note that the prices exclude VAT.
- Hire rates valid for weekday contracts commencing 6 am to 8 am.
- Morning pours commence prior to 8 am, afternoon pours after 1.00pm
- Night-time / out of hours / Sunday and Bank Holiday working will be quoted on request.
- Rates are for normal weight concrete without steel fibres. Special mixes quoted separately.
- Rates are for sites within 25 miles of our depot. More remote work quoted on request.

BOOKING CONDITIONS:

- Payment to be made by credit card for non-account customers. Minimum hire charge taken on confirmation of booking, the balance being taken on the completion of the pour.
- Confirmations must be made by 10:00 on the day prior to the pour. Saturday, Sunday and Monday pours should be confirmed on the Friday before the pour.
- Cancellation charges will be levied after 12 noon on the day prior to pour, with the full minimum hire being charged for cancellations made after 3pm.

ADDITIONAL INFORMATION:

- We are unable to guarantee to provide a particular pump or pump operator as we have to take account the needs of all of our customers as well as operator holidays and sickness. However, we will make every effort to oblige when & where we can.
- Concrete should not be called in until the operator has viewed the pump pour, safely set up and cycled the pump, they will then advise all is ready to commence pumping

CONDITIONS OF SUPPLY:

Concrete pumps are supplied according to the CPA Model Conditions for the Hiring of Plant (2021) in conjunction with the Supplementary Conditions for Concrete Pumping – (available to view on our website, copies can be emailed on request).

The main points are that the hirer is fully responsible for the management and supervision of the entire pumping operation including the provision of:

- Safe access and egress from site. Any damage to the pump inclusive of punctures will remain the hirers responsibility.
- Level hard-standing that is adequate to support the pump
- Cement to grout the pipeline
- Suitable concrete for the pumping operation
- Sufficient competent labour to carry out the work and to assist the pump operator
- A suitable place to wash out the pump and adequate protection of surrounding areas. It is the hirers responsibility to clear up any concrete spillages resulting from the pumping operation.
- Water to wash out the pump
- Insurance against any and all liabilities the hirer might incur, including damage caused when the boom is being operated in restricted locations.

CAUTIONARY NOTE:

Concrete is pumped at high pressure. Please ensure that all personnel are fully trained and aware of the risks and dangers associated with the use of pressurised pipelines and end placing hoses. Suitable PPE, including eye protection, must be worn.
